The Board of Directors of Hang Seng Bank Limited (the "Bank") today declared a **third interim dividend** in respect of the year ending 31 December 2016 of HK\$1.10 per share, which will be payable on Tuesday, 8 November 2016, to shareholders whose names appear on the Register of Shareholders of the Bank on Thursday, 20 October 2016.

The dividend as declared should not be taken as an indication of the level of profit or dividend for the full year of the Bank.
