Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the meeting other than those referred to in the notice convening the meeting and the supplemental notice.
- All resolutions will be put to vote by way of poll at the meeting. Every member of the Company present in person (in the case of a member being a corporation, by its duly authorized representative) or by proxy shall have one vote for every fully paid share of which he/she/it is the holder. A person entitled to more than one vote need not use all his/her votes or cast all the votes he/she uses in the same way and in such case, please state the relevant number of shares in the appropriate box(es) above.
- This Revised Proxy Form must be signed by you or your attorney duly authorized in writing or, in the case of a corporation, must be either executed under its common seal or under the hand of an officer or attorney or other person duly authorized.
- In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of votes of the other joint holder(s) and for this purpose seniority will be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- To be valid, this Revised Proxy Form together with the power of attorney (if any) or other authority (if any) under which it is signed or a notarially certified copy thereof, must be deposited at the Company's share registrar in Hong Kong (the "**Registrar**"), Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 48 hours before the time appointed for holding the meeting (i.e. not later than 3:00 p.m. on Wednesday, 6 June 2018 (Hong Kong time) or the adjourned meeting (the "**Closing Time**").
- As set out in the supplemental notice, resolution no. 14 is added in this Revised Proxy Form for your consideration and approval.
- If you have not yet lodged the form of proxy enclosed with the Company's circular dated 27 April 2018 (the "**First Proxy Form**") with the Registrar, you are requested to lodge this Revised Proxy Form if you wish to appoint proxy(ies) to attend the meeting on your behalf. In this case, the First Proxy Form should not be lodged with the Registrar.
- If you have already lodged the First Proxy Form with the Registrar, please note that:
 - If this Revised Proxy Form is not lodged with the Registrar, the First Proxy Form will be treated as a valid proxy form lodged by you if correctly completed. The proxy so appointed by you shall be required to vote in such manner as he/she/it may be directed under the First Proxy Form, and in respect of the added resolution no. 14 and any resolution properly put to the meeting other than those referred to in the notice and supplemental notice of the meeting, the proxy will be entitled to vote at his/her/its discretion or to abstain from voting on such resolution(s).
 - If this Revised Proxy Form is lodged with the Registrar before the Closing Time, this Revised Proxy Form will revoke and supersede the First Proxy Form previously lodged by you. This Revised Proxy Form will be treated as a valid form of proxy lodged by you if correctly completed.
 - If this Revised Proxy Form is lodged with the Registrar after the Closing Time, or if lodged before the Closing Time but is incorrectly completed, the proxy appointment under the Revised Proxy Form will be invalid. The First Proxy Form, if correctly completed, will be treated as a valid proxy form lodged by you.
