- 8. Any votes of abstention or abstention from voting shall be deemed as "abstained" for the number of H shares they represented. Any vote which is not filled or wrongly filled or illegible or not casted shall be deemed that the voter has waived the voting rights and the corresponding poll shall be counted as "abstained". Votes of abstention shall be regarded as valid votes casted when the Company takes poll in respect of the relevant matter.

To be valid, this form of proxy and, if such form is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be lodged to the Company's H Share Registrar in Hong Kong, Tricor Investor Services Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong not less than 24 hours before the time appointed for the holding of the H Shareholders Class Meeting or for the holding of any adjournment, or not less than 24 hours before the time appointed for taking the poll.
- 10. In the case of joint holders of shares of the Company, only the joint shareholders who ranked first in the register of members shall have the right to attend and vote at the H Shareholders Class Meeting. In the event that an H shareholder appoints more than one proxy to attend the H Shareholders Class Meeting, such proxies may only exercise their voting rights in a poll.
- 11. You are reminded that completion and return of the form of proxy will not preclude you from attending and voting in person at the H Shareholders Class Meeting or any adjournment thereof if you so wish. If you attend and vote at the H Shareholders Class Meeting, the authority of your proxy will be revoked.
