ANNOUNCEMENT IN RELATION TO KEY OPERATIONAL DATA IN THE THIRD QUARTER OF 2016

This announcement is made by China Communications Construction Company Limited (the "**Company**") pursuant to Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Hong Kong Laws) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The principal operating status of the Company for the third quarter of 2016 is set out as below, for the purpose of reference for the investors.

I. Principal operating status

In January to September 2016, the value of new contracts of the Company amounted to RMB475,380 million, representing a year-on-year increase of 10.10%. Wherein, the value of contracts of infrastructure construction business, infrastructure design business, dredging business, heavy machinery manufacturing business and other businesses amounted to RMB402,578 million, RMB19,846 million, RMB26,478 million, RMB21,073 million and RMB5,405 million, respectively.

The value of new contracts of all businesses from overseas markets amounted to RMB130,093 million (equivalent to approximately USD20,879 million), representing approximately 27.37% of the Company's new contracts value.

The value of new contracts of all businesses from investment projects amounted to RMB125,432 million, (among which, the contract value of share-participation projects on a shareholding pro-rata basis amounted to RMB20,515 million), accounting for approximately 26.39% of the value of new contracts of the Company. Wherein, the value of contracts of infrastructure construction business, infrastructure design business, dredging business and heavy machinery manufacturing business was RMB111,039 million, RMB3,424 million, RMB3,969 million and RMB7,000 million, respectively. During the process of designing and implementing the foregoing investment projects, the value of construction and installation contracts to be undertaken by the Company is estimated to be RMB111,084 million.
