1. During the month, 407,500 share options granted under the Pre-IPO Share Incentive Plan were vested.

2. On May 2, 2019, the Company granted an aggregate of 9,736,881 restricted shares to 8 grantees in accordance with the terms of the Innovent Biologics, Inc. 2018 Restricted Share Plan. Among them, the grant of 6,901,796 to Dr. De-Chao Michael Yu would be subject to approval by the independent shareholders of the Company at the forthcoming extraordinary general meeting of the Company.
