1. During the month, the 225,000 lapsed share options were unvested share options; 190,000 share options granted under the Pre-IPO Share Incentive Plan were vested. After deducting the exercised 2,625,000 share options, the number of new shares of the Company which may be issued pursuant to the vested and exercisable share options granted under the plan as at the close of the month is 11,200,000 shares.
