In particular, Average Daily Rate ("ADR") and Revenue Per Available Room ("RevPAR") as presented in the LVS Quarterly Report are based on gross room revenues as reported under US GAAP, which include associated promotional allowances within room revenues. Under US GAAP, promotional allowances are then deducted from total gross revenues in presenting net revenues. Under IFRS, room revenues exclude such promotional allowances. Our shareholders and potential investors in our ordinary shares should consult their own professional advisers for an understanding of the difference between IFRS and US GAAP. Our shareholders and potential investors in our ordinary shares are further advised that the consolidated financial results and related financial information set forth in the LVS Quarterly Report with respect to our Company's operating results have not been prepared or presented by our Company, and that because of the different accounting standards under which LVS and our Company report, the financial results and related financial information of our Company may not be the same as that presented in the LVS Quarterly Report.
