Completion and return of this form of proxy will not preclude you from attending and voting in person at the Domestic Shareholders' Class Meeting should you so wish.

A proxy attending the Domestic Shareholders' Class Meeting on behalf of a Shareholder shall present his/her identity card and the letter of attorney signed by the appointer or his/her representative with the issue date. A corporate Shareholder shall attend the Domestic Shareholders' Class Meeting by its legal representative or his/her nominee. A legal representative attending the Domestic Shareholders' Class Meeting shall present his/her identity card and document which can certify his/her capacity as a legal representative. A nominee attending the Domestic Shareholders' Class Meeting shall present his/her identity card and the letter of attorney signed by the legal representative.
