Based on the information currently available to the Company, the Board believes that the major reason attributable to the expected substantial decrease in profit is rising labour costs resulting in great increase in production costs.

The Company is still in the process of finalising the financial statements of the Group for the year ended 31 March 2014. The information contained in this announcement is only a preliminary assessment made by the Board based on the management accounts of the Group and currently available information which have not been reviewed or audited by the Company's auditors. The announcement for the annual results of the Group for the year ended 31 March 2014 is expected to be released in June 2014.
