As of 30 September 2019, (i) 77,641,330 shares of the issuer may be issued pursuant to the exercise of the share options granted pursuant to the issuer's pre-IPO employee stock incentive scheme; (ii) 740,000 shares of the issuer may be issued pursuant to the exercise of the share options granted pursuant to the issuer's post-IPO share option scheme; (iii) 96,946,141 shares of the issuer may be issued pursuant to the vesting of the restricted share units granted pursuant to the issuer's pre-IPO employee stock incentive scheme; and (iv) 48,483,965 shares of the issuer may be issued pursuant to the vesting of the award shares granted pursuant to the issuer's post-IPO share award scheme.
