IF YOU WISH TO ABSTAIN FROM VOTING, PLEASE PLACE A "\" IN THE BOX MARKED "ABSTAIN". If the form returned is duly signed but without specific direction on any of the proposed resolutions, the proxy is entitled to vote or abstain at his discretion in respect of all resolutions; or if in respect of a particular proposed resolution there is no specific direction, the proxy is entitled, in relation to that particular proposed resolution, to vote or abstain at his discretion. A proxy will also be entitled to vote at his discretion on any resolution properly put to the Domestic Shareholders' Class Meeting other than those set out in the notice convening the Domestic Shareholders' Class Meeting. The shares abstained will be counted in the calculation of the required majority.
- 5. This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a legal person, must either be executed under seal or under the hand of legal representative or an attorney duly authorized to sign the same. If this form of proxy is signed by an attorney of the appointer, the power of attorney authorizing that attorney to sign, or other document of authorization, must be notarized.
- 6. Where there are joint holders of any shares, the one whose name stands first in the register of members of domestic shares shall alone be entitled to attend and vote at the Domestic Shareholders' Class Meeting in respect of such shares.
- 7. In order to be valid, this form of proxy together with any power of attorney or other documents of authorization (if any) must be deposited at the registered office of the Company at 27th and 28th Floor, China World Office 2, 1 Jianguomenwai Avenue, Chaoyang District, Beijing, the PRC not later than 24 hours before the time of the Domestic Shareholders' Class Meeting or any adjourned meeting thereof.
