If the form returned is duly signed but without specific direction on any of the proposed resolutions, the proxy is entitled to vote or abstain at his discretion in respect of all resolutions; or if in respect of a particular proposed resolution there is no specific direction, the proxy is entitled, in relation to that particular proposed resolution, to vote or abstain at his discretion. A proxy will also be entitled to vote at his discretion on any resolution properly put to the H Shareholders' Class Meeting other than those set out in the notice convening the H Shareholders' Class Meeting.
- 6. This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a legal person, must be either executed under its common seal or under the hand of its legal representative or attorney or other officer duly authorized.
- 7. If an attending shareholder or proxy casts a vote of abstention or abstains from voting in respect of a resolution, the Share(s) represented by that shareholder or proxy will be regarded as valid votes when the Company counts the votes with respect to that resolution.
- 8. To be valid, this form of proxy and, if such proxy is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be delivered to the Company's H Share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours before the time for holding of the H Shareholders' Class Meeting or any adjournment thereof, i.e. 11:00 a.m. on Monday, May 20, 2019.
- 9. In the event that a Shareholder appoints more than one proxy to attend the H Shareholders' Class Meeting, such proxies may only exercise their voting rights in a poll.
- 10. You are reminded that completion and return of the form of proxy will not preclude you from attending and voting in person at the H Shareholders' Class Meeting or any adjournment thereof if you so wish.
