The difference between the closing balance reported in the prior Next Day Disclosure Return filed on November 1, 2019 (the “**NDDR**”) and the corresponding figure in this monthly return is due to the options exercised by the Company’s non-director employees on the last business day of October 2019. Due to the time zone difference between the United States and Hong Kong, the administrator of the Company’s equity plans, which is based in the United States, only provided information regarding such option exercises after the NDDR was filed. Therefore, the Company was not aware of some of the options exercised on the NDDR filing date so that the closing balance reported in the NDDR did not take into account of such option exercises.
