- (iv) all the securities of each class are in all respects identical (Note 3);
- (v) all documents required by the Companies (Winding Up and Miscellaneous Provisions) Ordinance to be filed with the Registrar of Companies have been duly filed and that compliance has been made with other legal requirements;
- (vi) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue;
- (vii) completion has taken place of the purchase by the issuer of all property shown in the listing document to have been purchased or agreed to be purchased by it and the purchase consideration for all such property has been duly satisfied; and
- (viii) the trust deed/deed poll relating to the debenture, loan stock, notes or bonds has been completed and executed, and particulars thereof, if so required by law, have been filed with the Registrar of Companies.

Remarks (if any):

As disclosed in the announcement issued by the Company on 9 May 2019, Ningbo Meishan Bonded Area Yingxiang Investment Centre (Limited Partnership) and the Company entered into the First Domestic Share Subscription Agreement, pursuant to which, Ningbo Meishan Bonded Area Yingxiang Investment Centre (Limited Partnership) has agreed to subscribe for, and the Company has agreed to issue and allot, 12,580,645 Domestic Shares of the Company at the subscription price of RMB6.2 (equivalent to approximately HK\$7.19) per Domestic Share. Shares will be issued after obtaining the approval from the shareholders at the extraordinary general meeting of the Company and that all conditional precedents set out in the agreement have been fulfilled.

Reference is made to the announcements of the Company dated 22 May 2019 and 28 May 2019 in relation to the subscription of a total of 7,300,000 Domestic Shares by seven subscribers pursuant to the Second Domestic Share Subscription Agreements (after execution of the Termination Agreement) at the subscription price of RMB6.2 (equivalent to approximately HK\$7.19) per Domestic Share. Shares will be issued after that all conditional precedents set out in the agreements have been fulfilled.

A total of 19,880,645 Domestic Shares will be issued once the transactions afore-said transactions have been approved in the EGM.
