**(I) PROPOSED AMENDMENTS TO THE CURRENT MEMORANDUM AND ARTICLES OF ASSOCIATION; AND (II) THE ADOPTION OF THE SECOND AMENDED AND RESTATED MEMORANDUM AND ARTICLES OF ASSOCIATION**

This announcement is made pursuant to Rule 13.51(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

Having comprehensively considered the global development trend in corporate governance, the board (the “**Board**”) of directors (the “**Directors**” and each, a “**Director**”) of IGG Inc (the “**Company**”) proposed to make certain amendments (the “**Proposed Amendments**”) to the current memorandum of association and articles of association of the Company in order to provide a further enhanced and flexible corporate governance system. The Proposed Amendments include, among others, provisions which permit the Company to hold hybrid general meetings and general meetings by electronic means and certain housekeeping amendments to ensure compliance with the Listing Rules. The Board also proposed to adopt the second amended and restated memorandum of association and articles of association of the Company incorporating all the Proposed Amendments (the “**Second Amended and Restated Memorandum and Articles of Association**”). Please refer to the Appendix to this announcement for details of the Proposed Amendments.

The Proposed Amendments as well as the adoption of the Second Amended and Restated Memorandum and Articles of Association are subject to approval by the shareholders of the Company at the extraordinary general meeting of the Company. A circular of the Company containing detailed information of the Proposed Amendments as well as the adoption of the Second Amended and Restated Memorandum and Articles of Association and the notice of the extraordinary general meeting will be dispatched to the shareholders of the Company in due course.
