Whether or not you are able to attend the EGM, you are requested to complete the enclosed form of proxy in accordance with the instructions printed thereon and return it to the Company's Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding the EGM or any adjournment thereof. Completion and return of the form of proxy will not preclude you from attending and voting in person at the EGM or any adjournment thereof should you so wish.

PRECAUTIONARY MEASURES FOR THE EGM

In order to prevent the spread of COVID-19 pandemic and to safeguard the health and safety of Shareholders, the Company will limit attendance in person at the EGM venue to 50 persons (including Shareholders and supporting staff for the EGM). Shareholders exceeding an estimated number of 40 cannot be accommodated.

The following precautionary measures will also be taken at the EGM to safeguard the health and safety of Shareholders who might be attending the EGM in person:

1. Compulsory temperature checks;
2. Compulsory wearing of surgical face mask;
3. Any person who has travelled outside Hong Kong within 14 days immediately before the EGM (“Recent Travel History”) and is subject to quarantine or self-quarantine in relation to COVID-19, or has close contact with any person under quarantine or with Recent Travel History, shall not attend the EGM; and
4. No refreshments or drinks will be served and no gifts will be distributed.

To the extent permitted under the laws of Hong Kong, the Company reserves the right to deny any person's entry into the EGM venue or require any person to leave the EGM venue in order to ensure the safety of the attendees at the EGM.

INTRODUCTION

Reference is made to the announcement of the Company dated 5 June 2020 in relation to, among other things, the Proposed Amendments.

LETTER FROM THE BOARD

The purpose of this circular is to provide you with information in relation to the proposed amendments to the Current Memorandum and Articles of Association and the adoption of the Second Amended and Restated Memorandum and Articles of Association and to give you the EGM Notice.

PROPOSED AMENDMENTS TO THE CURRENT MEMORANDUM AND ARTICLES OF ASSOCIATION AND THE ADOPTION OF THE SECOND AMENDED AND RESTATED MEMORANDUM AND ARTICLES OF ASSOCIATION

Having comprehensively considered the global development trend in corporate governance, the Board proposed to make the Proposed Amendments in order to provide a further enhanced and flexible corporate governance system. The Proposed Amendments include, among others, provisions which permit the Company to hold hybrid general meetings and general meetings by electronic means and certain housekeeping amendments to ensure compliance with the Listing Rules. The Board also proposed to adopt the Second Amended and Restated Memorandum and Articles of Association incorporating all the Proposed Amendments.

Details of the Proposed Amendments are set out in Appendix I to this circular.

The Proposed Amendments as well as the adoption of the Second Amended and Restated Memorandum and Articles of Association are subject to the approval of the Shareholders by passing a special resolution at the EGM.

The Directors consider that the Proposed Amendments are in the interest of the Company and the Shareholders as a whole. Confirmation has been obtained from independent legal advisers that the Proposed Amendments comply with the laws of the Cayman Islands and the applicable Listing Rules requirements. The Company also confirms that there is nothing unusual in the Proposed Amendments from the perspective of a Cayman Islands company listed on the Stock Exchange.

EGM AND PROXY ARRANGEMENT

The EGM Notice is set out on pages 48 to 50 of this circular. At the EGM, a special resolution relating to the amendments to the Current Memorandum and Articles of Association and the adoption of the Second Amended and Restated Memorandum and Articles of Association will be proposed.

For determining the entitlement to attend and vote at the EGM, the register of members of the Company will be closed from Tuesday, 23 June 2020 to Tuesday, 30 June 2020, both days inclusive, during which period no transfer of Shares will be effected. In order to qualify for attending and voting at the EGM, all transfers of Shares, accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited, at Shops 1712-1716, 17th Floor, Hopewell Centre 183 Queen's Road East, Wanchai, Hong Kong, for registration not later than 4:30 p.m. on Monday, 22 June 2020.

A form of proxy for use at the EGM is enclosed with this circular. Whether or not you are able to attend the EGM, you are requested to complete the form of proxy and return it to the Company's Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, in accordance with the instructions printed thereon not less than 48 hours before the time fixed for the EGM or at any adjournment thereof. The completion and return of a form of proxy will not preclude you from attending and voting at the EGM in person should you so wish and in such event the instrument appointing a proxy shall be deemed to be revoked.

According to the Rule 13.39(4) of the Listing Rules and Article 66 of the Current Memorandum and Articles of Association, all votes at the EGM will be taken by poll.

PRECAUTIONARY MEASURES FOR THE EGM

Pursuant to section 5(3) of the Prevention and Control of Disease (Prohibition on Group Gathering) (Amendment) (No. 2) Regulation 2020 (the "**Regulation**") which came into effect on 8 May 2020, a group gatherings of more than 50 persons for a shareholders' meeting are required to be accommodated in separate partitioned rooms or areas of not more than 50 persons each.

To comply with the Regulation, the Company will limit attendance in person at the EGM venue to 50 persons (including Shareholders and supporting staff for the EGM). Shareholders exceeding an estimated number of 40 cannot be accommodated. This arrangement takes into consideration the current condition of COVID-19 pandemic and the requirement to keep appropriate social distancing for the health and safety of Shareholders.

To safeguard the health and safety of Shareholders who might be attending the EGM in person, the Company will also implement the following measures at the EGM venue:

- (1) Compulsory temperature checks will be carried out on every person at the main entrance of the EGM venue. Any person with a body temperature of above 37.4 degree celsius or is exhibiting flu-like symptoms may be denied entry into the EGM venue and be requested to leave the EGM venue.
- (2) Every attendee will be required to wear a surgical face mask throughout the EGM and sit at an appropriate social distance from other attendees. Please note that no masks will be provided at the EGM venue and attendees should prepare their own masks.
- (3) Any person who has travelled outside Hong Kong within 14 days immediately before the EGM ("**Recent Travel History**") and is subject to quarantine or self-quarantine in relation to COVID-19, or has close contact with any person under quarantine or with Recent Travel History, shall not attend the EGM.

- (4) Any person who declines any of the abovementioned measures will be denied entry into the EGM venue.
- (5) No refreshments or drinks will be served, and no gifts will be distributed.

To the extent permitted under the laws of Hong Kong, the Company reserves the right to deny any person's entry into the EGM venue or require any person to leave the EGM venue in order to ensure the safety of the attendees at the EGM.

For the health and safety of Shareholders, Shareholders are strongly encouraged to exercise their rights to vote at the EGM by appointing the chairman of the EGM as their proxy to vote on the relevant resolution at the meeting as an alternative to attending the EGM in person. Shareholders are reminded that physical attendance is not necessary for the purpose of exercising Shareholders' voting rights.

RECOMMENDATION

The Directors consider that the resolution proposed in the EGM Notice are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend that the Shareholders to vote in favour of the resolution to be proposed at the EGM.

RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company.
