Net Generation of Subsidiary Power Plants in the First Six Months of 2017 Increased by 8.5%

China Resources Power Holdings Company Limited (“CR Power”, stock code: 0836) today announced that total net generation of subsidiary power plants in June 2017 increased by 18.0% to 14,172,493MWh from 12,010,040MWh for the same period of 2016. Total net generation of subsidiary power plants for the first six months of 2017 increased by 8.5% to 76,978,660MWh compared to 70,958,229MWh for the same period last year.

On a same plant basis, total net generation of subsidiary coal-fired power plants for the first six months of 2017 increased by 3.4% compared to the same period of 2016. Power plants located in Guangdong, Hubei, Hebei, Jiangsu and Other provinces recorded 11.3%, 10.7%, 7.9%, 0.1% and 5.0% increases year on year, respectively. Power plants located in Henan recorded 5.1% decrease year on year.
