Net Generation of Subsidiary Power Plants in the First Nine Months of 2017 Increased by 6.9%

China Resources Power Holdings Company Limited ("CR Power", stock code: 0836) today announced that total net generation of subsidiary power plants in September 2017 decreased by 8.1% to 12,402,732 MWh from 13,500,568 MWh for the same period of 2016. Total net generation of subsidiary power plants for the first nine months of 2017 increased by 6.9% to 120,250,133 MWh compared to 112,443,393 MWh for the same period last year.

On a same plant basis, total net generation of subsidiary coal-fired power plants for the first nine months of 2017 increased by 2.4% compared to the same period of 2016.
