Net Generation of Subsidiary Power Plants in the First Nine Months of 2018 Increased by 2.7%

China Resources Power Holdings Company Limited ("CR Power", stock code: 0836) today announced that total net generation of subsidiary power plants in September 2018 increased by 0.6% to 12,130,617MWh from 12,055,259MWh for the same period of 2017. Total net generation of subsidiary power plants for the first nine months of 2018 increased by 2.7% to 119,226,648MWh compared to 116,097,339MWh for the same period last year.

On a same plant basis, total net generation of subsidiary coal-fired power plants for the first nine months of 2018 increased by 0.2% compared to the same period of 2017. Power plants located in Hubei, Hebei, Guangdong and Other provinces recorded 16.7%, 6.6%, 0.5% and 7.1% increases year on year, respectively.
