## Net Generation of Subsidiary Power Plants in the First Ten Months of 2019 Decreased by 3.7%

China Resources Power Holdings Company Limited ("CR Power", stock code: 0836) today announced that total net generation of subsidiary power plants in October 2019 increased by 8.6% to 11,051,194MWh from 10,173,506MWh for the same period of 2018. Total net generation of subsidiary power plants for the first ten months of 2019 decreased by 3.7% to 120,765,609MWh compared to 125,429,833MWh for the same period last year. (Note: The above generation volume does not include the volume sold to independent third parties.)

On a same plant basis, total net generation of subsidiary coal-fired power plants for the first ten months of 2019 decreased by 6.8% compared to the same period of 2018. Power plants located in Hubei recorded 11.4% increase year on year. Power plants located in Henan, Guangdong, Jiangsu, Hebei and Other provinces recorded 17.6%, 8.9%, 6.8%, 3.5% and 8.0% decreases year on year, respectively.
