#### **PROPOSED PLACING OF EXISTING SHARES BY A CONTROLLING SHAREHOLDER**

This announcement is made by CBK Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company announces that it has been informed by Sure Wonder Investments Limited (定妙投資有限公司) (“**Sure Wonder**”), the immediate controlling shareholder of the Company (as defined under the GEM Listing Rules), that on 16 August 2019 (after trading hours), it has entered into a placing agreement (the “**Placing Agreement**”) with Kingsway Financial Services Group Limited which has been appointed as Sure Wonder’s placing agent (the “**Placing Agent**”) for a placing of up to 265,000,000 existing shares of the Company (the “**Shares**”) held by Sure Wonder (the “**Placing Shares**”), representing approximately 22.08% of the total issued share capital of the Company as at the date of this announcement, to investors procured by or on behalf of the Placing Agent at a price of not less than HK\$0.253 per Placing Share on a best efforts basis for a placing period from 16 August 2019 and ending at 5 p.m. on 16 September 2019 (unless otherwise terminated earlier) (the “**Placing**”).

Assuming all the 265,000,000 Placing Shares are placed by the Placing Agent and there is no change in the total issued share capital of the Company prior to completion of the Placing, the shareholding of Sure Wonder in the Company will be reduced from 854,200,000 Shares, representing approximately 71.18% of the total issued capital of the Company, to 589,200,000 Shares, representing approximately 49.1% of the total issued capital of the Company, upon completion of the Placing, and Sure Wonder will remain a controlling shareholder of the Company. The Directors believe that the Placing will not have any adverse effect on the operation of the Group.

Further announcement will be made to provide update on the Placing if and when necessary.
