IF YOU WISH TO VOTE AGAINST ANY RESOLUTIONS, PLEASE TICK THE APPROPRIATE BOXES MARKED "AGAINST".** Failure to complete any or all the boxes will entitle your proxy to cast his/her votes at his/her discretion. Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the meeting other than those referred to in the notice convening the meeting.
- All resolutions will be put to vote by way of poll at the meeting. Every Member present in person (in the case of a Member being a corporation, by its duly authorised representative) or by proxy shall have one vote for every fully paid share of which he/she/it is the holder. A person entitled to more than one vote need not use all his/her votes or cast all the votes he/she uses in the same way and in such cases, please state the relevant number of shares in the appropriate box(es) above.
- This revised form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be either executed under its common seal or under the hand of an officer or attorney or other person duly authorised.
- To be valid, this revised form of proxy together with the power of attorney (if any) or other authority (if any) under which it is signed or a certified copy thereof, must be deposited at the Company's branch share registrar in Hong Kong, Tricor Investor Services Limited ("Branch Share Registrar") at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong, by 2:30 p.m. on Monday, 6 August 2018 or not later than 48 hours before the time fixed for holding this meeting or the adjourned meeting ("Closing Time").
- In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of votes of the other joint holder(s) and for this purpose, seniority will be determined by the order in which the names of the joint holders stand in the Register of Members of the Company in respect of the joint holding.
- Completion and delivery of the revised form of proxy will not preclude you from attending and voting at the meeting and, in such event, the revised form of proxy shall be deemed to be revoked.

IMPORTANT

A MEMBER WHO HAS ALREADY LODGED THE FORM OF PROXY WHICH WAS SENT TOGETHER WITH THE NOTICE OF THE MEETING DATED 29 JUNE 2018 (THE "ORIGINAL PROXY FORM") SHOULD NOTE THAT:

- if no revised form of proxy is lodged with the Branch Share Registrar, the Original Proxy Form, if correctly completed will be treated as a valid proxy form lodged by the Member but the proxy so appointed will not be entitled to vote on Resolutions no. 4 and 5;
- if this revised form of proxy is lodged with the Branch Share Registrar by the Closing Time, such revised form of proxy, if correctly completed, will be treated as a valid proxy form lodged by the Member and will revoke and supersede the Original Proxy Form previously lodged by the Member; and
- if this revised form of proxy is lodged with the Branch Share Registrar after the Closing Time, or if lodged before the Closing Time but is incorrectly completed, the proxy appointment under the revised form of proxy will be invalid. The Original Proxy Form, if correctly completed, will be treated as a valid proxy form lodged by Member. The proxy/proxies so appointed by the Member under the Original Proxy Form will be entitled to vote in the manner as mentioned in (i) above as if no revised form of proxy was lodged with the Branch Share Registrar.
