ANNOUNCEMENT POWER GENERATION FOR OCTOBER 2016

The board of directors (the "**Board**") of China Longyuan Power Group Corporation Limited* (the "**Company**") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "**Group**") for October 2016 on a consolidated basis amounted to 3,599,873 MWh, representing an increase of 19.44% compared with the corresponding period of 2015. In particular, the wind power generation registered an increase of 24.51%, the coal power generation registered a decrease of 4.64% and other renewable energy power generation registered a decrease of 16.60%. As of 31 October 2016, the total power generation of the Group for 2016 amounted to 32,595,224 MWh, representing an increase of 10.04% compared with the corresponding period of 2015. In particular, the wind power generation registered an increase of 13.10%, the coal power generation registered an increase of 14.41%.
