The board of directors (the "Board") of China Longyuan Power Group Corporation Limited* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for November 2018 on a consolidated basis amounted to 4,170,358 MWh, representing a decrease of 9.97% compared with the corresponding period of 2017. In particular, the wind power generation registered a decrease of 14.81%, the coal power generation registered an increase of 13.11% and other renewable energy power generation registered a decrease of 29.23%. As of 30 November 2018, the total power generation of the Group for 2018 amounted to 44,713,226 MWh, representing an increase of 8.89% compared with the corresponding period of 2017. In particular, the wind power generation registered an increase of 14.19%, the coal power generation registered a decrease of 6.75%, and other renewable energy power generation registered a decrease of 19.19%.
