The board of directors (the "Board") of China Longyuan Power Group Corporation Limited* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for February 2019 on a consolidated basis amounted to 4,135,370 MWh, representing an increase of 5.46% compared with the corresponding period of 2018. In particular, the wind power generation registered an increase of 2.19%, the coal power generation registered an increase of 23.84% and other renewable energy power generation registered an increase of 4.28%. As of 28 February 2019, the total power generation of the Group for 2019 amounted to 8,630,645 MWh, representing a decrease of 2.63% compared with the corresponding period of 2018. In particular, the wind power generation registered a decrease of 3.69%, the coal power generation registered an increase of 2.22%, and other renewable energy power generation registered a decrease of 2.77%.
