The board of directors (the "Board") of China Longyuan Power Group Corporation Limited* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for September 2019 on a consolidated basis amounted to 3,361,658 MWh, representing a decrease of 6.55% compared with the corresponding period of 2018. In particular, the wind power generation registered a decrease of 7.05%, the coal power generation registered a decrease of 1.32% and other renewable energy power generation registered a decrease of 48.99%. As of 30 September 2019, the total power generation of the Group for 2019 amounted to 36,597,184 MWh, representing an increase of 0.38% compared with the corresponding period of 2018. In particular, the wind power generation registered an increase of 0.88%, the coal power generation registered a decrease of 1.67%, and other renewable energy power generation registered an increase of 1.41%.
