## ANNOUNCEMENT POWER GENERATION FOR NOVEMBER 2019

The board of directors (the "**Board**") of China Longyuan Power Group Corporation Limited\* (the "**Company**") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "**Group**") for November 2019 on a consolidated basis amounted to 4,945,054 MWh, representing an increase of 18.58% compared with the corresponding period of 2018. In particular, the wind power generation registered an increase of 27.65%, the coal power generation registered a decrease of 10.89% and other renewable energy power generation of the Group for 2019 amounted to 45,595,669 MWh, representing an increase of 1.97% compared with the corresponding period of 2018. In particular, the wind power generation registered an increase of 3.43%, the coal power generation registered a decrease of 3.67%, and other renewable energy power generation registered a decrease of 1.78%.
