 Pursuant to the conditional sale and purchase agreement dated 18 February 2015 (the "S&P Agreement") entered into between Sino Virtue Holdings Limited (the "Vendor"), Esteemed Zone Limited (the "Purchaser") (a wholly-owned subsidiary of the company), and the guarantors pursuant to which the Purchaser has conditionally agreed to acquire, and the Vendor has conditionally agreed to sell, (i) the entire issued share capital of and (ii) the sale loan due by E-Innovation Limited at a total consideration of HK\$800,000,000 (the "Acquisition"). The consideration will be satisfied as to HK\$30,000,000 in cash within two months after signing of the S&P Agreement; as to HK\$450,000,000 in cash upon completion; and as to HK\$200,000,000 by issue of the bond upon completion; and as to HK\$200,000,000 by allotment and issue of the 398,009,950 consideration shares by the Company at an issue price of HK\$0.5025 each. The Acquisition is subject to the Company's shareholders' approval requirements pursuant to the listing rules and the consideration shares will be allotted and issued pursuant to the specific mandate to be obtained at the special general meeting of the Company.
